2. Rules

FIS rules will be applied to this competition:

- Georgian Ski Federation , Mountain Resorts Development Company and the organizing committee of the FIS Snowboard World Cup – Snowboard Cross are organizing the FIS Snowboard Cross World Cup on February 4th and 5th, in Bakuriani ski resort, “Didveli” Mountain.
- The competition will be held under FIS rules and regulations of Snowboard.
- This competition is a Snowboard Cross event and is open to both Men and Women.
- This competition will follow an official program that will be available to all participants

The organizing committee reserves the right to change the schedule depending on the snow conditions, weather after confirmation of the competition jury.

3. Entries

Registration/Entries

Entries will be accepted in accordance with the FIS quotas and rules.

All entries must be done using the FIS Online Registration System, through the FIS home page: <http://www.fis-ski.com/> "Member Section". FIS has established Nation Quotas for World Cups. National Ski Teams can only enter World Cup Competitors according to the Quota limitations. The Quotas can be downloaded: <https://www.fis-ski.com/en/inside-fis/document-library/snowboard-documents>

Deadlines for Team Entries:

Final Entries: 21st February 2021

Competitors entered into FIS Snowboard World Cups must have the minimum required FIS Snowboard Cross points in one of the valid FIS points list. The minimum FIS point requirements per FIS Snowboard Cross World Cup event are:

Standards / Requirements	SBX FIS Points
Basic Quota BQ & Personal WC spots	75 +
Additional WC Quota AQ,	125

4. Registration and means of Payment

- All teams are responsible to arrive and register at race office – located in Hotel “Crystal ” on the first Team Captain’s meeting, March 1st.
- Accommodation with Half Board for the dates: 1-5 March 2021, is CHF 80 per person per night.

“No Shows” will be charged to the National Associations by LLC
“TRIFECTA.”

Important information: To accommodate all athletes, coaches and officials in a correct way, we do need your updated Preliminary Team Entries as soon as possible, January 31st, 2021, the latest.

After the above mentioned Deadline for Team Entries the FIS rate for hotel accommodation can’t be guaranteed anymore.

Participation Fee

According to the FIS Snowboard/Freestyle Ski/Freeski World Cup Rules (art 4.4) a mandatory Participation Fee of CHF 30 per each competitor, official training, qualification and competition day, total CHF 120 has to be paid to the organizing committee. According to the FIS C-19 temporary regulations and based on the agreement together with the SBX NSA’s the “C-19 prize money support fee” of 200.- CHF will be added to the regular participation fee, per athlete and competition, only once and for the second competition day Friday the 5th.

Payment

The Participation Fee has to be paid at the Race Office in credit card.

5. Bibs

All competitors must wear their bibs during the official training, competition, and awards ceremony after the competition.

6. Prize Money

Prize money will be distributed according to the WC Rules

7. Transfer

- Participants are responsible for their own transportation. Bakuriani ski resort is located 190 km away from Tbilisi international airport , The OC offers transfers between the airport of Tbilisi and the resort (busses, mini vans for teams and trucks for equipment). Transfer requests are to be sent to office trifecta@gmail.com and should include the following information:
 1. Arrival/departure date, time, flight numbers, destination (from/to)
 2. Amount of passengers and all names of participants in a group
 3. Amount of luggage in pieces and its approximate total weight.
- Transportation on site will be provided by the OC and will be free of charge.
- The accommodation and transfer request should be sent no later than 16th of February 2021
- Competitors, coaches and OC key staff will be accommodated in Hotel “Crystal”

- Every Competitor must be individually medically insured. The Organizing Committee: Georgian ski Federation, Mountain Resorts Development Company and the FIS will not be held responsible for accidents or damaged equipment during the training and competition.

11. Accident Protocol

- In case of an accident on the course during the event, medical staff from the Organizing Committee and Ski Patrol will be responsible for any medical decision or evacuation to the Tbilisi Medical Centre or local hospital.
