#### **Expenses**

The reimbursement of the expenses will occur according to the FIS World Cup rules for Ski Jumping 2021/2022 – for all Teams right after Team Captains' meeting in Topolšica, for Officials and Judges on their Bank Accounts (please fill Expenses Sheet Form available on FIS site and Bank Transfer Form available in this Invitation).

Accommodation costs: Teams will pay directly in the Hotel. Payment by credit card only.

Travel money and Nation support: The bank transfer form for team reimbursement/prize money is available on FIS website and has to be filled out electronically in advance and sent to info@ljubno-skoki.si (or brought directly to the OC race office at Ski Jumping Hill). Please note that the prize money, nation support and travel money is in the same form.
